Earnest money deposit shall be in the form of Demand draft of any scheduled bank drawn in favor of The Principal, **GOPAL GOVIND POY RAITURCAR COLLEGE OF COMMERCE AND ECONOMICS** Farmagudi and payable at Ponda only. Such Demand draft is to be enclosed with the tender in a separate envelope, duly super scribed as **EMD FOR THE WORK OF CONSTRUCTION OF ANNEXE BUILDING TO GGPR COLLEGE FARMAGUDI** . Earnest money deposit in any other form including hard cash shall not be accepted.

The intending tenderers applying for the above work shall have to fulfill the below mentioned **Eligibility Conditions**:

The contractor should have satisfactorily completed one work costing minimum of Rs **10292100/-** or two works costing each work of minimum **5146100/-** or three works minimum of **Rs 3216300/-** each. Certificates of satisfactory completion of works shall have to be appended with application form.
2. The Contractor should have valid registration with EPF, **ESIC and GST** as on the date of application. Attested copies of all above registration certificates shall be attached with application form.
- 4) Individuals or agencies applying for the above work should produce permanent account number (PAN CARD) issued by the Income Tax Department in the name of firm or Individual (in case of Proprietor) duly attested by Gazetted Officer along with the application.

All relevant documents as above should be enclosed along with the application to be eligible to obtain tender form.
